



1. What elected office are the campaigning for and why?

I am running for the Clerk of Court/Comptroller role for Jefferson County because of my desire to restore people's trust in this office. I love this county and want to use the skills I have acquired over the last 18 years to serve our citizens by protecting their tax dollars and delivering exceptional customer service.

### 2. How are your education, work/life experience and/or certifications relevant to successfully fulfilling the duties of the office you seek?

An important role for Clerk of Court is being the Chief Financial Officer for our County and is responsible for the disbursement of payments, processing payroll, investing County funds and preparing annual reports, among other duties. Having worked for Farmers and Merchants Bank and the City of Tallahassee Treasurer-Clerk's Office I have acquired the knowledge in private banking and government finance to fulfill these job duties. The prior duties I had at Farmers and Merchants Bank were balancing general ledger accounts, working overdrafts and return checks, cash handling, ACH and wire processing, online banking and debit card support, and fraud monitoring. My current duties in the City of Tallahassee Treasury-Management Division include balancing several accounts for the City and Consolidated Dispatch Agency, handling investments/contracts for City funds, preparing agenda items for City Commission

meetings, coding and approving purchase card transactions in our financial system, preparing and compiling data for the annual report to bondholders, preparing reports for the Investment Advisory Board committee, and processing wire and ACH payments for accounts payable and payroll. I believe all these duties will be applicable and translate to the Clerk position. Additionally, they will help me review current policies and procedures for possible improvements.

3. Have you ever been convicted of a crime or disciplined for professional misconduct? If so, what happened and when?

No, I have never been convicted of any crimes or disciplined for misconduct.

4. What is an issue relevant to the office you seek, and how would you address it if elected?

The biggest issue I see in the Clerk's Office is the lack of transparency and trust, especially regarding the financial side of the office. We need to

# implement checks and balances or modify/reinforce the ones in place to ensure we are getting the appropriate results. Current processes need to be reviewed to see if we can increase security, improve efficiency, or lower costs.

# 5. If elected, how could you use your office to better the local community?

If elected to this office I would use all means possible to provide the highest level of customer service by offering as many services as allowed through our

website, but also being able to assist people who would rather come in-person. Additionally, if elected I would invest the County's funds to bring in additional income to allow the County to provide additional services for our residents. One option is to invest in a local government investment pool with low risk, daily available cash, with some currently paying over 5%. Being a smaller county with a smaller budget we must make every dollar count.

6. What is one way you stand out from other candidates seeking the same office?

My detailed work experience in finance sets me apart from other candidates in this race and I believe that is vital for the position. Not only would I have the experience to oversee the day-to-day operations, but I would have the ability to be hands-on and investigate any problems first-hand. Attention to detail, especially with financials, would help quickly identify any discrepancies or anomalies that warrant further consideration.
