



else; we are proud that you are a part of Jefferson County.



JEFFERSON COUNTY: THE BEGINNING

The history of Jefferson County is generally thought to have begun when native tribes began migrating into the region from farther north. This theory, at least, had long been the conventional wisdom, until recent discoveries at the Page-Ladson site in the Aucilla River and others around the country began to put into question man's first habitation of the Americas. Regardless the origins, as the centuries proceeded, the indigenous people of the region came into contact with strange men who wore metal armor and employed steel weapons: the Spanish conquistadors.

The Spaniards were the first to arrive and built their missions in order to convert the Indians, or possibly to lure Spanish settlers to the new lands.

By the early 19th century, however, the territory came into the hands of mostly British colonists who had recently won their independence from Great Britain. Andrew Jackson wrested the Territory of Florida from Spain in 1821 and it wasn't long afterwards that word began spreading up the eastern seaboard that the red clay of Florida made excellent land for planting cotton.

When the Territory of Florida was accepted into the United States in 1822, Pensacola and St. Augustine were the only existing towns. In an effort to establish a compromise capital between the two existing towns, a council in 1824 created Leon County, with boundaries that extended from the Ochlocknee River on the west to the Suwannee River on the east, and from the Georgia border to the Gulf of Mexico.

The search for land by prospective settlers began in 1824, but was complicated by major legal and geographic problems. Some of the land in Middle Florida, as the region was then called, was one of the richest and most productive in the world; but it was also interspersed with swamps and sand hills, which made cultivation impossible in some areas.

Moreover, there were two legal problems: One was that much of the land, which was now in the possession of the United States, had not been surveyed; the second was the many land applicants argued their cases on the basis of Spanish grants or settlements prior to the U.S. acquiring the territory.

One of the largest legal battles fought was because of a Spanish grant involving the Forbes Purchase, representing more than a million acres that stretched between the St. Marks and Apalachicola rivers along the Gulf Coast.

Settlement on this large tract of land entangled settlers for

many years, casting doubt on land titles and disrupting the settlement of Magnolia, where much of the trade of Jefferson County citizens took place.

Even so, early Jefferson County settlers managed to acquire their lands through numerous means. For example, James Gadsden, who came to Florida with Andrew Jackson, in 1818 was able to acquire acreage as an original settler; he later purchased more land from the government at a minimum price.

In the northern part of the county, near Monticello, brothers

William, John and Abram Bellamy purchased land from the original settlers, as well as from the government. Some of the early settlers to the area, before the county was established, were John Robison, Asa Townsend, Joseph W. White, Daniel S. Graham, Martin Palmer, William Blackburn, Thomas Randolph, and Joseph Watts. Along with these men, 21 others made the journey to the future Jefferson County in hopes of acquiring land and carving out a name for

themselves.

The earliest community that preceded the county's creation was Waukeenah. This community sprawled along the St. Augustine Road from the Leon County line to present-day Capps. Some of the men who joined Gadsden and Achille Murat, the nephew of French Emperor Napoleon Bonaparte, in the early settling of Jefferson County were John and Robert Gamble, Edmund Vass, Abram Cabell, William Nuttall, Thomas Randall, Cornelius Beasley and Thomas Moore.

At the site of what would soon become Monticello, a post office named Robison was established on May 10, 1826. Then in January 1827, the eastern part of Leon County was split to form Jefferson County, a political subdivision that stretched from the Georgia border on the north to the Gulf of Mexico on the south, and from the eastern shore of Lake Miccosukee on the west to the Suwannee River on the east.

By December 1827, the council found it necessary once again to divide the region. Madison County was then taken from Jefferson County's eastern portion, with the Aucilla River becoming the boundary between the two. Meanwhile, Jefferson County's western boundary was also slightly adjusted in 1832 and again in the 1870s. These latter adjustments, however, proved relatively minor.

Today, Jefferson County encompasses about 560 square miles or 358,400 acres. It is bordered by Leon on the west, the Aucilla River on the east, Georgia on the north and the Gulf of Mexico on the south.

JEFFERSON COUNTY FACT SHEET

Jefferson County's population is 15,450, according to the 2023 U.S. Census, up 1 percent from the 2020 U.S. Census count of the 14,520.

Jefferson County is part of the Tallahassee Metropolitan Statistical Area.

Jefferson County was created in 1827 and named for Thomas Jefferson, third president of the United States of America, who served from 1801 to 1809. Monticello was named after Jefferson's home in Virginia.

Forts of Jefferson County

Fort Roger Jones: established in 1839 at Aucilla (Ocilla Ferry), north of US 90.

Fort Noel: established in 1839–1842 south of Lamont on the Aucilla River, six miles northwest of Fort Pleasant in Taylor County; also known as Fort Number Three (M).

Camp Carter: established in 1838 near Waukeenah.

Fort Welaunee: established in 1838 as a settlers' fort on the Welaunee Plantation near Wacissa. Fort Gamble (1839–1843) was later established here.

Fort Aucilla: established in 1843, two miles southeast of Fort Gamble, southwest of Lamont, between the Aucilla and Wacissa rivers; also spelled Ocilla.

Fort Wacissa: established in 1838 as a settlers' fort south of Wacissa on the Wacissa River, west of Cabbage Grove.

Geography

The county encompasses an area of 636.65 square miles, of which 597.74 square miles (or 93.89%) is land and 38.91 square miles (or 6.11%) is water.

Jefferson County is the only



county in Florida that borders both the state of Georgia and the Gulf of Mexico, giving it the nickname of “The Keystone County.”

Major Highways

Interstate 10 (I-10) is the main west to east interstate highway in the county and serves as the unofficial dividing line between northern and southern parts of Jefferson County.

It contains three interchanges within the county: the first is SR-59 in Lloyd (Exit 217); the second is US 19 in Drifton (Exit 225); and the third is south of Aucilla at CR-257 (Exit 233). East of Jefferson, I-10 runs through Madison County, and west it runs through Leon County.

U.S. 19 is the westernmost north/south US highway in Jefferson County. It enters the county at the southwestern corner of the Madison County as the Georgia-Florida Parkway concurrent with U.S. 27; it then breaks away from U.S. 27 at Capps and runs straight north through Monticello, where it encounters U.S. 90 at the traffic circle around the historic courthouse and continues north into, and through, Georgia.

U.S. 27 is another north/south

U.S. highway that crosses Jefferson County. It enters from Madison County on the east concurrent with U.S. 19, but unlike U.S. 19, it breaks away at Capps and runs west toward Leon County and Tallahassee before proceeding north into Georgia.

U.S. 90 was the main west/east highway in Jefferson County, until it was surpassed by I-10. U.S. 90 enters the county twice from Leon County, the second time forming a causeway over the southern end of Lake Miccosukee. U.S. 90 eventually enters Monticello from the west and intersects with U.S. 19 at the traffic circle.

East of the city, U.S. 90 curves southeast through rural Jefferson County, passes north of the small community of Aucilla, and crosses into Madison County at the Aucilla River.

U.S. 98 is the southernmost east/west route running through the southernmost part of the county near the Gulf of Mexico. It largely runs through conservation areas. U.S. 98 comes into Jefferson from Taylor County in the east and goes into Wakulla County on the west. Its sole major intersection is with SR-59.

COMMUNITIES OF JEFFERSON COUNTY

The towns of Jefferson County are “where heaven smiles down on earth”

Ashville - This community, in the northern part of the county, started as a country store operated by James Morris and Samuel Sessions in the late 1830s. The location eventually came to be known as Rhodes Store, and by the late 19th Century, it was renamed Ashville.

Aucilla - Originally called Williamsburg, this community on the eastern part of the county also began as a store in 1845. It was later renamed Aucilla when the Pensacola and Georgia Railroad came through. In the 1800s, common spellings of the town’s name were “Ocilla” and “Oscilla.”

Drifton - In the late 1850s, the railroad company established its Station No. 3 around the small settlement of Walker’s Mills, a few miles south of Monticello. At the time, the location consisted of a depot, several mills and a store. The community grew and was renamed Drifton in the 1870s.

Lamont - Originally referred to as Beasley’s Store, this community in the southeastern part of the county was renamed McKanes’ Store shortly before the Civil War; it was also sometimes called “Lick Skillet.” It was renamed “Lamont” in the 1880s, but for a long time afterwards, it was still occasionally called by its former names.

Lloyd - Bailey’s Mills, in the western part of the county, was established in the early part of the 1800s and grew into a large farming community when the railroad came through. By the mid-1800s, the town’s name had changed to Lloyd in honor of Walter F. Lloyd, who had established the first post office and built the town.

Monticello - Established in 1827 in the northern part of the county not far from the Georgia border, the town is the seat of county government and also the hub of the business community. The town boasts one of the largest collections of restored and registered historic homes and buildings in the state, with its historic district encompassing 27 blocks and nearly 600 buildings constructed before 1930.

Wacissa - During the Antebellum Period, many people expected this small community in the southern part of the county to become a major port town at the head of the navigable Wacissa and Aucilla rivers. Today Wacissa is best

known as the gateway to the Wacissa River, a pristine waterway popular with its share of fishermen, boaters, canoeists and other outdoors enthusiasts.

Waukeelah - Located in the middle of the county, Waukeelah in the mid-1800s was the second largest community in Jefferson County and home to two of the area’s largest plantations: Waukeelah and Welaunee. Today Waukeelah remains a viable community along the much traveled US 27.

Animal Services

The rural life of Jefferson County is enhanced by furry and feathered friends of all types — dogs, horses, cats, chickens, and cattle. Livestock, in fact, is as much a part of Jefferson County as its human residents. It is no surprise, then, that compassionate animal services are easy to come by.

ELECTRICITY

Electricity in Jefferson County comes from two companies: Duke Energy and Tri-County Electric Cooperative, Inc.

Duke Energy, headquartered in Charlotte, NC, is the county’s largest electric power holding company. It serves customers within the City of Monticello and in the unincorporated parts of the county. 

The City of Monticello, Florida

Established in 1827, the City of Monticello, in the northern part of Jefferson County is located a few miles south of the Georgia border in the beautiful Red Hills country. A small, historic community and Main Street City, Monticello has a population of 2,788.

Monticello serves as the seat of county government, with the iconic Classical Revival-style county courthouse at its heart.

Monticello is not only Jefferson County's largest population center but also one rich in culture and history, with an abundance of architectural jewels, among which it numbers the 1909-built cupola-topped courthouse, the 1890-built Opera House and the late 1800s built Wirick-Simmons House. Explore the town's tree-lined streets and you will find, nestled among the trees and flowering shrubs, numerous antebellum and Victorian homes dating from the early 1900s and late 1800s,

giving the city a unique look and feel.

The many preserved historical houses is partly because during the Great Depression of the 1930s, many of Monticello's residents couldn't afford to build new homes, so they generally renovated or restored their houses. Today, these homes offer tourists a rare glimpse of the original architectural styles that prevailed in the South prior to the Civil War.

Monticello has a modified form of government that consists of a five-member City Council, a mayor and a city manager. The city has 30-plus full-time employees, including the Monticello Police, and it has a volunteer fire department that's backed by the county's paid fire department. The Monticello City Council meets once a month on the first Tuesday at 7 p.m. in City Hall, which is located just south of the police station at 245 S. Mulberry Street.

On a more mundane note, newcomers may be pleased to know that the city provides a full array of services, including water, sewer, trash collections, recycling and police and fire protection. A trip to City Hall will familiarize you with these services and also get your new home connected to the various utilities.







Shanna Boutwell serves as the county's tax collector. Besides collecting property taxes, Boutwell and her staff are also responsible for the collection of other taxes set at the local level, including those levied by

special districts and state agencies. The tax collector also acts as an agent of several state departments, including the Florida Department of Revenue, the Florida Department of Highway Safety and Motor Vehicles, and the Florida Fish and Wildlife Conservation Commission.

The tax collector is a fee office, its budget approved by the Florida Department of Revenue. The office operates on the fees imposed for services rendered.

VEHICLE REGISTRATION

After you purchase or enter the state with a new or used car, the state of Florida requires that you shortly afterward register the vehicle for a 12-month period (primary owner's birthday to birthday) with the Florida Division of Motor Vehicles (FDMV).

A non-transferable registration consists of the following items: (1) A serial-numbered validation decal to be placed on a license plate attached in a visible place on the rear of the vehicle; and (2), a registration certificate (a copy of which must be kept handy in your vehicle at all times as you may be asked to present it to any law-enforcement officer in case of an accident or an alleged traffic law violation or infraction).

Registration will require that you bring with you to the FDMV office: (1) Proof of Florida insurance (issued or countersigned by Florida agent); (2) the vehicle title; (3) proof of identity (a driver license with photo or current passport); and (4) payment of fees and taxes, including an initial fee of \$225.

Chapter 320 of Florida Statutes enumerates these requirements. For more complete information, visit the Tax Collector's website at www.jeffersoncountytaxcollectors.com.

Many of the responsibilities at the Property Appraiser's office are calendar driven. This is a synopsis of those dates and how they may affect you as a property owner.

The beginning of each year is a very important time as far as property taxes are concerned because Florida Statutes requires that property be valued based on its condition and ownership status as of January 1st. This "freeze date" can cause some confusion later in the year, but nonetheless is what should be followed.

March 1 is the deadline to file for homestead or other property tax exemptions. It is also the deadline to file for agricultural or conservation classification. If you are a business owner, you may need to file your Tangible Personal Property Return. Those are due on April 1. If you file for a Low Income Senior Exemption, the deadline to submit income documentation is June 1.

All property owners receive a Truth in Millage (TRIM) Notice toward the end of August. The notice lists proposed property values and taxes for the entire year, based on the condition and ownership status on January 1. If you do not agree with the assessed value of your property or you have a question about an exemption, this is the time to call the Property Appraiser's office to discuss the matter.

If, after speaking with an appraiser you are still dissatisfied with the value or exemption status, you have 25 days from the mailing of the notice to file a petition with the Value Adjustment Board.

In October, the tax roll is certified and submitted to the Tax Collector. The Tax Collector mails tax bills on Nov. 1.

Elected officials play an important role in the quality of life of Jefferson County. To cast your vote for those you trust the most, you need to register to vote at the office of the Supervisor of Elections. You can pick up an application to register to vote at the public library, Monticello City Hall, or at the elections office.

Registration is simple. Just submit the application and you will receive your voter registration card by mail soon afterward.

Remember to carry your photo ID with you to the polls when you go to vote.

Since December 2005, the voting system allows anyone, regardless of disability, to be able to vote independently. The tabulator will reject the vote of a voter who over-votes. In 2022, the paper books for signing in at the polls were replaced with electronic sign-in. Also in 2022, 10-year redistricting process for the Florida House of Representatives resulted in a new map that significantly affected Jefferson County. Precincts remained the same, but Jefferson County voters who live north of U.S. 27 are now in Florida House District 9, whereas those south of U.S. 27 are in Florida House District 7.

School board races are nonpartisan. This means that voters are able to vote for any school board candidates in their district, regardless of the political party affiliation of the voter or the candidate.

In Florida, we have a "universal ballot," which means that if there is no opposition in the general election, then all voters, regardless of party affiliation, are able to





rate.” says Farm Credit lender, Charlotte Dodson. “One lender may offer a lower interest rate but could have higher fees which add to your total cost.” She suggests buyers look at the whole picture the rate, the points, and the fees associated with each loan to determine which lender provides the best offer.

Another piece of advice from Dodson: “You can never be too prepared when applying for your mortgage.” Here are a few tips to help you out.

Shape Up Your Credit Score

Whether this is your first home purchase or your fifth, all buyers should know lenders look closely at potential mortgage payments relative to a buyer’s monthly income and debts. You can use the mortgage calculator on Farm Credit’s home loan information page to estimate your monthly payment based on your down payment, interest rate, and length of the mortgage. As part of your formal application for a mortgage your lender will perform a thorough review of

your financial status. In addition to an examination of your income, assets, and employment, your lender will check your credit score, a sort of “report card” detailing your ability to pay bills on time and how much debt you carry. Don’t know your credit score? Check it for free at *creditscore.com* and then discover what steps you can take to improve it if necessary.

Get Finances & Documents in Order

The key to having a smooth mortgage loan experience is getting your financial papers in order. As mentioned above, your lender will request a number of key documents such as recent pay stubs, bank statements, and your last two years of tax returns. As you collect these documents, take a close look at your monthly bills and credit cards. Are you carrying large balances? If possible, reduce or eliminate them. Your lender will pay special attention to your debt-to-income (all of your monthly debt payments

divided by your monthly income). If it’s out of whack, you may be considered a higher risk, reducing the amount for which you qualify. Tip: Don’t apply for any other lines of credit or close any credit cards in the weeks prior to applying for your mortgage as these actions could negatively affect your credit score.

Pre-Qualified vs. Pre-Approved

When you begin the home buying process, it’s often a good idea to get pre-qualified or pre-approved for a loan. Let’s take a look at the differences. To be “pre-qualified,” means you’ve verbally detailed your financial situation to a lender and based on that information, the lender will provide you with a letter noting the maximum price you can afford in a home. You can share it with agents and sellers as initial proof of your buying power. To be “pre-approved” means your lender has done a thorough review and verification of your income, assets, employment, and credit check to determine you’re qualified for a loan. You’ll receive what’s known as a “preapproval letter” for an exact loan amount. This letter tells sellers you’re a solid bet as a buyer. Pre-approval puts you on the fast track to securing your loan and will allow you to finalize a deal more quickly when you find the home you want. However, pre-approval is subject to your financial condition not materially changing. Don’t take on new debt, close credit card accounts, quit your job or any other significant action prior to closing your loan.

Five Terms to Know

If you’re buying a home for the first time, you may encounter unfamiliar real estate jargon. Here’s a look at five of the most common terms you’ll see:

1. Closing Costs: These include items like appraisal fee, title insurance fees, pre-paid interest and documentation fees. They differ for each customer due to differences in the type of mortgage, the property location and other factors. Your Loan Estimate

will detail the estimated closing costs associated with your loan.

2. Escrow Account: This account will be used to collect your payments for property taxes, homeowner’s insurance and possibly other items, in equal amounts over a 12-month period, to be paid on your behalf when those bills come due.

3. Mortgage Insurance: Mortgage insurance protects the lender against taking a financial loss in the event you, the buyer, stop making payments. It is required on mortgage programs requiring little or no down payment when the lender’s exposure is greater than 80% of the purchase price or appraised value, whichever is less. The mortgage insurance premium is typically included in your monthly mortgage payment.

4. Title Insurance: Lender’s title insurance protects your lender against problems with the title that might occur such as someone with a claim against your property. To protect your personal financial investment, you may want to purchase an Owner’s title insurance policy, which protects you for any personal costs incurred if a fault in the title is found.

5. Homestead Exemption: Homeowners in Florida are eligible to receive a valuable tax savings option called the Homestead Exemption. Your exemption can be up to \$50,000 and the amount of property tax you owe is calculated based on the difference between your home’s value less the exemption amount. To be eligible you must be a permanent resident of Florida who owns & occupies the property as of January 1 of the year in which you are applying for the exemption. The normal filing time for a

Homestead Exemption begins on January 1 and lasts through March 1. Your application must be filed in person at the County Property Appraiser’s office. Once you make application you will receive an automatic renewal card and as long as there is no change, no action is required on your part.







HEALTH DEPARTMENT

The Jefferson County Health Department (JCHD) serves clients with a wide range of services. Kimberly Allbritton is the administrator. The Department of Health in Jefferson County (DOH-Jefferson) is responsible for helping keep Jefferson County residents and its environment healthy.

Residents can access health care and environmental services at the DOH-Jefferson clinic, including:

- Women’s health services
- STD and HIV/AIDS testing and treatment
- Immunizations for children and adults
- Woman, Infants and Children (WIC)
- Septic tank permitting and inspection

RECREATION PARKS

The Jefferson County Recreation

Department administers all recreation and maintenance programs of the public recreation facilities in Jefferson County, particularly the park on Mamie Scott Drive, where the office is located.

The recreation park offers playground areas, tennis, pickle ball and racquetball courts, baseball and softball field, concession stand, restroom, a covered picnic area and a paved exercise path for walking and running. Monticello Ecological Park

is a work in progress. This 28-acre park is located on South Water Street, with its entrance at the intersection of Seminole Street, adjacent the American Legion Building. This park has several trails, some of which are elevated to give a view of the canopy. It offers a slice of the flora and fauna of north Florida. Good for walking, hiking and bird watching. Dr. Jordan Memorial Park is a small showcase pocket park in the northeast part town. The park is located on Pearl Street, between Johnson and Marvin streets, and adjacent to the Woman's Club. The park is named in honor of the late Dr. Reginald Jordon, a local veterinarian, musician and book lover. Nestled in a residential neighborhood, the park has benches, walkways, playground equipment, a gazebo and a reading garden. It's open sunrise to sunset. Monticello/Ike Anderson Bike Trail

is a multiple mile biking and hiking trail that runs from Rocky Branch Road on the north side of town to Nacoosa Road on the south side. The trail, which is paved for more than two miles, crosses a few residential neighborhoods and then turns into a dirt trail that ends near Simpson Nurseries. The trail is named after Ike Anderson, a lifetime Monticello resident who was an attorney and longterm mayor. A colorful and popular figure, Anderson could often be seen riding his bicycle about town.

Monticello Health & Fitness

Center on East Washington Street is a state-of-the-art facility offering everything you could want in a gym. Located within walking distance of the courthouse, this facility is a 'must see.' Ways to explore the scenic outdoors

CANOEING, KAYAKING AND HIKING

Canoe or kayak on the Wacissa River, one of the most pristine waterways in North Florida. Stop to swim or snorkel in one of the many springs that feed the river. In the spring, you'll find hardwood hammock islands covered with zephyr lilies and wild iris. In the late summer, scores of swallow-tailed kites gather in the cypresses along the river before their annual migration to South America for the winter.


Or hike along the Aucilla Sinks Trail beneath a canopy of oaks, hickory and magnolia. You'll pass sinkholes and caves created by the Aucilla River as it rises and falls, disappearing underground and resurfacing. The extensive river floodplains provide excellent food and cover for deer and other wildlife.

BIKING

There are bicycling opportunities along the approximately 10 miles of trails within the Western Sloughs area, accessible from U.S. 98.

PADDLING

Twelve major spring



feed into the Wacissa River as it winds its way through swampy lowlands. The water is generally clear and the springs may be explored with snorkel equipment. Access to the springs is by boat. The suggested trail is 14 miles long and begins one mile south of the community of Wacissa, about a quarter mile south of State Road 59.

FISHING

Aucilla Wildlife Management Area offers several different fishing opportunities. The Western Sloughs are popular with bank fishermen who target red breast sunfish, red ear

sunfish (shell cracker), spotted sunfish (stump knocker), bluegill and largemouth bass. The Wacissa River offers many angling opportunities for various species of bream, a freshwater fish. Early mornings out of Goose Pasture campground can be productive for largemouth bass. The Wacissa is one of a handful of rivers in North Florida with Suwannee bass, a cousin of the largemouth bass.

HUNTING

The Small Game Hunting Area south of U.S. 98 and the Western Sloughs are popular with squirrel hunters, and many of the small animals are harvested in both locations each year. Hogs also abound in the area, particularly on the central portion west of the Wacissa River. Turkey hunters can find great opportunities in some of the higher areas in the Western Sloughs and along the Aucilla River south of Goose Pasture Road. Some of the areas popular with turkey hunters should also be productive for deer because of the abundance of mass-producing tree species.

CAMPING

Camping is allowed along the Wacissa River at the Goose Pasture campground. The camping area is open on a first-come, first-served basis by self-issued special-use authorization, which is available at a kiosk on the grounds. Campers are limited to a 10-day stay. Camping is not allowed during the Aucilla Wildlife Management Area's general gun season. Primitive camping (tents only) is allowed at designated sites along the Florida Trail only by permit from the Suwannee River Water Management District. Roads and Trails for your enjoyment

Aucilla River Trail

For 7.1 miles, from Goose Pasture Road to Wakulla Springs Bridge, this trail follows the east bank of the Aucilla River. The banks are high and heavily wooded with steep gradients and rocky outcrops that produce a number of shoals and ledges.

Aucilla River Canoe Trail

The dark waters of the Aucilla River pass between high limestone banks and dense hardwood forests in some sections and swampy areas of cypresses and gums in others. The "Big Rapid" is a rock-strewn drop of 8-10 feet that runs about 30 yards. The trail starts one mile south of Lamont on U.S. Highways 19 and 27.

Aucilla Sinks Trail

According to Elizabeth E. Carter in A

Hiking Guide to Florida, "Searching for sinkholes makes for a fascinating hike since sinks in the woods are heavily forested with beautiful magnolias, oaks and other hardwoods." Along the trails are such named sinks as Chocolate, Mosquito Slap, Hurry Up, Kitchen, Long Suffering, Watts, Frink, Sunshine and Long and Breakdown. If you cross Goose Pasture Road and walk 0.2 miles, you'll see roadside Overflow Sinks and the Silver Blaze Tree, a 1984 commemoration of the completion of a major connection of the Florida Trail.

Heritage Roads

More than simply canopy roads, Heritage Roads offer a glimpse into Jefferson County's past. These roads traverse the county's diverse and scenic topography, including its rolling hills, pastoral farms, working ranches,

productive timberlands and the dramatic drop from the elevation of the Cody Escarpment to the Flatwoods.


Historic sites alongside the Heritage Roads shed insight into the exploits of the area's early settlers and explorers, whether they were Native Americans, Spaniards, Britons or Americans, as well as give a sense of the present activities on the land.

The Heritage Road System consists of four named Trails. (1) The Micosukee-Magnolia Trail (northwest); (2) the Plantation Trail (northeast); the Spanish Trace Trail (central); and (4), the Flatwoods-Wilderness Trail (southern). The trails mostly follow canopy and scenic roads, travel past historic sites and points of interest and cross a few small communities. 




Genealogical Society






